 - **HESAA requires the FAFSA is processed by 4/15/17 to be considered for NJ TAG and EOF!**

- Complete the 'state application' for New Jersey on the FAFSA confirmation page.

NEW JERSEY ADDITIONAL INFORMATION QUESTIONS


Higher Education Student Assistance Authority (HESAA)

New Jersey requires additional data elements, other than what is reported on the FAFSA, to determine a student's eligibility for a Tuition Aid Grant (TAG) award, NJ STARS & NJ STARS II and Governor's Urban Scholarship.

These elements include:

- ✓ Driver license information
- ✓ Veterans education benefits (independent students)
- ✓ Untaxed Social Security benefits
- ✓ Earned income credit

Once students have completed the FAFSA, they must select the second option on the confirmation page to report this information to HESAA.

FINANCIAL AID TIMELINE

FAFSA

- **2017-2018 FAFSA** must be filed **by April 15th** to be eligible for NJ TAG
- Use **2015** income to file the 2017-2018 FAFSA

Verification and Awarding

- February 2017 – Verification process begins: check your PAWS To Do List and TCNJ Email. **Submit your documents now while you are still on campus!**
- June - Awarding begins for continuing students on a weekly basis

Billing and De-Registration

- July – Fall bill email notifications are sent (Office of Student Accounts) and first payment is due for the Installment Payment Plan.
- August – Fall bill is due
- August – De-Registration

GRANTS

- Pell Grant: Federal grant awarded on the basis of need and college costs.
 - **2017-2018** - maximum award \$5,920
- Tuition Aid Grant (TAG): State grant awarded on the basis of need, cost of attendance and available funding.
 - **2016-2017 @TCNJ: \$2,000 - 9,120**
*(the new award amounts for **2017-2018** have not been received)*
- NJ ED Opportunity Fund (EOF): Standard EOF grant awarded to all students in the program.
 - **2017-2018: \$1150 (commuter) and \$1400 (on campus)**
- Supplemental Opportunity Grant (SEOG): Awarded to the neediest students as defined by the FAFSA (zero EFC). SEOG funding is limited.
 - **2016-2017: \$1500**
 - *(2017-2018 have not been determined)*

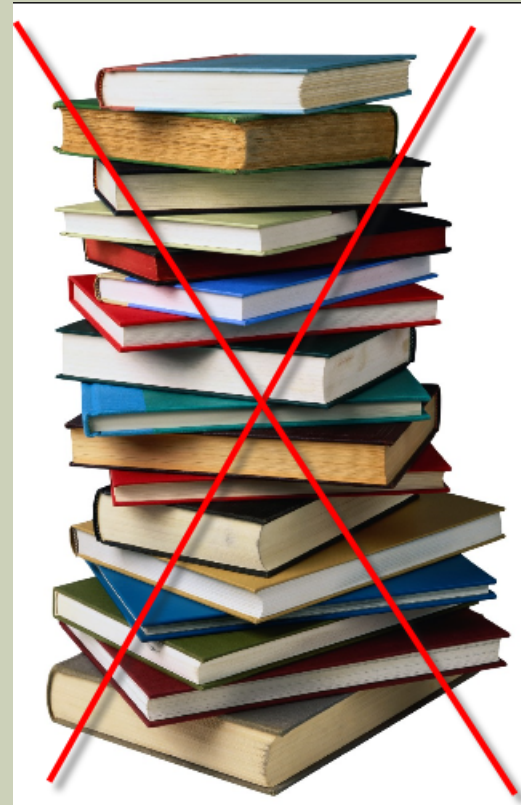

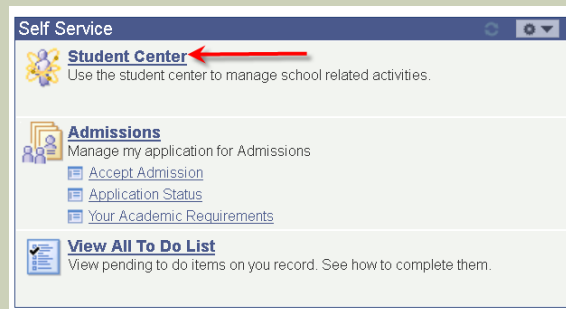

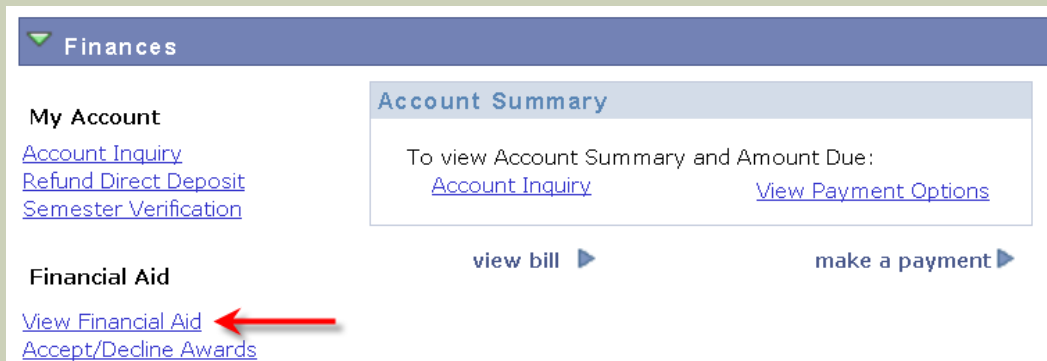

BUDGETING: LIVING OFF CAMPUS

Living off campus requires planning! Below are steps to help determine if living off campus is affordable for you!

- 1. What are the ‘estimated’ expenses? (rent, food, electric, cable, cell, TCNJ parking permit, books, miscellaneous, etc.)**
- 2. What is your ‘estimated Financial Aid for the Fall and Spring for next year?’ Review the total amount of your current Financial Aid in PAWS. Make an appointment with a Financial Aid Counselor to discuss Stafford Loan options which are based on your ‘academic level’ not your year at TCNJ.**
- 3. Subtract the Estimated Financial Aid from the current Tuition and Fees for Fall and Spring. If you have an excess amount this is an estimated refund for you to pay your expenses.**
- 4. Refund checks are not issued until September (Fall semester) and February (Spring semester. **You must budget your Fall refund to last you until your Spring refund.****

SUMMER FINANCIAL AID

Financial Aid for Summer Programs Students

- **Complete the 2017 TCNJ Summer Session Financial Aid Application in PAWS.** Instructions are on our website: <http://financialaid.pages.tcnj.edu/sources-of-financial-aid/financial-assistance-for-summer-programs-students/>
- Your financial aid file must be complete by **June (date posted to website in May)**.
- You must have made **Satisfactory Academic Progress** at the end of the Spring semester to be considered for Summer assistance.
- Must be enrolled half-time
 - **Undergraduate students - enrollment hours of at least 1.5 units**

Types of Financial Aid

- Federal Stafford Loans – based on remaining eligibility from the previous academic year.
- Federal Direct Plus Loan Denial – if not used during the academic year
- Private Loans – students will need a co-signer unless parent or another third party applies for the loan.
- Private scholarships

WINTER FINANCIAL AID

- Application: TCNJ Winter Session Financial Aid Application in PAWS
- Priority deadline to complete the winter application is **December 2017**.
- * *We cannot guarantee that your financial aid will be processed by the time your bill is due for applications received after this date.*
- Required enrollment: Must be enrolled in at least 1.5 units for Undergraduate Students
- **For Winter Financial Aid the course-load total is determined by combining the Fall semester with the Winter session units/credits.*
- Disbursement – No aid is disbursed until Winter Session courses begin.
- Aid Programs: Federal Direct Loan Program, PLUS Loan, Alternative Loans.
- **Limited financial assistance is available for students attending Winter Session at TCNJ. This assistance will be based on remaining eligibility from the Fall semester.*

TO DO LIST

■ FEBRUARY – MAY

- **File the 2017-2018 FAFSA by April 15th if you have not filed.**
- **To receive NJ Tuition Aid Grant your FAFSA MUST BE FILED BY APRIL 15th!**
- Monitor your TCNJ Email and PAWS To Do List for Financial Aid items needed to complete your file. **Submit all documents TIMELY!!!**
- Meet with a Financial Aid Counselor to develop a plan of action for next year!
 - What are Stafford Loans? Do I need to take the full amount of Stafford Loans?
 - Do I need to prepare for applying for a private loan? What is the process?
 - Who do I budget to live off campus?
 - Other questions?

■ MAY-JUNE

- Monitor your **NJ HESAA Account** and mail. **Submit documents TIMELY!** If you do not understand how to complete a document call HESAA or contact our office for guidance. **DO NOT WAIT UNTIL AUGUST TO SUBMIT DOCUMENTS AND ASK FOR HELP!**

■ JUNE-AUGUST

- Monitor your TCNJ email for your Financial Aid Award Notification. Emails are sent on a weekly basis.
- Review your tuition bill in July and begin to implement your plan of action in June!
- **Submit to NJ HESAA all required documents as requested. HESAA verification deadline is 9/15/17!**
